Description/Summary of Item:

The 2024 Inter-Regional Report is a data-oriented summary of demographic changes and travel characteristics for a 28-county study area centering on the WILMAPCO region. This 2024 update utilizes more recent data from the U.S. Census Bureau, metropolitan planning organizations, and other agencies to provide detailed maps and analysis of a series of transportation and demographic trends. The report also includes an analysis of key regional corridors and updates on inter-regional planning activities.

The 2024 Inter-Regional Report was presented to the PAC on February 12, 2024, but no action was taken.
