- c. DelDOT funded additional monies to shift design to minimize or avoid future conflicts with bulkhead work. This delayed PS & E.
- d. Easement needed for mid-block crossing.
- e. Revised final plans have been circulated with comments/review due 8/16.
- f. Seeking PS & E this fall.
- g. Construction anticipated Spring/Summer 2025.

2. T201620011 Southbridge Streetscape Improvements Phase II (New Castle County)

- b. Project delayed due to city's overlapping project for storm drain/sewer line separation.
- c. We have sponsor financial participation dating back to 2019, but may seek for more due to delay (inflation/time/increase price).
- d. Traffic signal breakout (early action) completed June 2023.

3. T202320003 Southbridge Streetscape Improvements Phase III (New Castle County)

- a. Semi-Final Plans circulated and plan comments needing to be addressed (current).
- b. Final plans this fall.
- c. PS & E advertisement goal is early 2025 (Jan/Feb).
- d. Housing development project in project limits will be completing a sidewalk portion...no further action and this component will be removed from design.
- e. Will need sponsor agreement (City of Wilm.) and 20% match which influences PS & E scheduling.

4. T202220001 New Castle Avenue Area Sidewalks and Streetscapes (New Castle County)

- a. Final plans are being circulated with comments due end of August.
- b. 8 Temporary Construction Easements needed (i.e., right of way plan involvement).
- c. PS & E hopeful for December or January predicated on signed agreements and finances.
- d. Agreements needed with sponsor (New Castle County) for finances and landscaping.
- e. Sponsor needs to process full 20% participation based on revised and current construction estimate (note: there was scope increase requested by sponsor). This is an expensive project thus far for TAP.
- f. Added sections may be removed if sponsor cannot provide adequate or level of match (i.e., which will likely alter projected schedule).

5. T202320011 Frederica Road Pedestrian Improvements (Kent County)

- a. Final plans have been circulated with comments due early Sept.
- b. PS & E submittal scheduled for November/December.
- c. Easements and right to trespass needed from multiple property owners including the Town. This process started.
- d. Agreements needed with Town and for its financial sponsor match. This will influence PS & E scheduling along with securing all right of way/easement needs upfront.
- e. Minor addition to final plans may be warranted (i.e., DART Comment for bus pad).
- f. Assuming agreements and PS & E in place, construction in spring/summer 2025.

6. T202120003 Old Brandywine Village, Streetscape Improvements, Phase II (New Castle County)

- a. Final plans expected this fall.
- b. Still needing agreements with City of Wilmington; right of way/easements expected.
- c. Construction aimed for Summer 25.

7. T202320009 Old Brandywine Village, Streetscape Improvements, Phase III (New Castle County)

- a. Likely improvement at Jessup St./Vandever Ave only. The CTP 12th Street Connector project may dictate the level and effort of TAP elements. This project could be put on hold to confirm elements of 12th Street and one-way directions of city streets (Jessup) and traffic signals.
- b. Concept planning stage effort TBD, but funding set up for expected use.

8. T202320005 Newark, Paper Mill Road, Olan Thomas Park Path (New Castle County)

- a. PE design: preliminary plans out and comments reviewed with simi-final plan distribution expected this fall.
- b. Still needing town agreements with City of Newark; right of way/easements expected.
- c. Utility pole adjustment needed which may drive the up overall cost.
- d. Aiming for summer/fall 2025 construction.

9. T202320014 Townsend Sidewalk Walkability (New Castle County)

- a. Planning and concept efforts complete this past spring. Much of overall scope and effort with estimations is predicated and took into consideration what could be funded for construction.
- b. Setting up PE design funding (current) after confirming elements and level of funding that would be needed for future construction. No sponsor match under SRTS.
- c. CTF 60K contributed & will apply towards construction. Project limited to approx. 300K unless town (or state) can provide additional match.
- d. Survey plan stage expected end of year.

10. T202320015 Midtown Brandywine Streetscape (New Castle County)

- a. Planning concept feasibility complete this early summer.
- b. Outreach to community (July) on what components to move forward into design and construction.
- c. CTF provided to fund PE engineering design.

- d. Sponsor/City of Wilmington to provide match for construction. Limited to 100K match for 500K project from what we know.
- e. Seeking PE engineering design proposal this August/Sept for project set-up.

11. T202320016 Tri Parks Pedestrian Improvements (New Castle County)

- a. Concept planning efforts on-going and to be complete this fall.
- b. Public workshop on concept expected before end of the year. Preliminary estimates need to be determined for PE engineering design.
- c. Effort will not be implementing solar lighting.

12. T202321002 Safe Routes to School, First State Montessori Academy (New Castle County)

- a. A series of smaller crossing refinements were developed for the City of Wilmington to implement at intersections. That effort coordinated and accepted this past spring/summer.
- b. This effort has been handed off to the City of Wilmington Public Works to implement.

13. T202320021 S. Walnut Street Streetscape Milford (Sussex County)

- a. Efforts may follow planning and concept effort undertaken for the complete corridor by the city.
- b. The TAP project intends to program missing sidewalk areas or other elements that may not dictate the cross-section solution for this corridor area.
- c. Concept Planning or PE engineering design is not scheduled. The city has asked us to hold off.
- d. Meeting coordination scheduled August 30, but this is reflected with other projects. However, this project location status will be brought up. It is possible that project is suspended and reapply when ready and definitive. The TAP program does not award projects only for the sponsor to advise the Department to put project on indefinite hold (or slot as a placeholder) until ready.

14. T202320019 Sussex Drive Streetscape, Lewes (Sussex County)

- a. Concept design and feasibility assessment begin this spring and summer.
- b. Meeting with City/sponsor, DelDOT consultant, and Resident Stakeholders on July 26 (note: no DelDOT representatives) to understand the degree of expected improvements.
- c. Public workshop to be scheduled September 12.
- d. Project not expected to address parking, school pick up needs, roadway standards, or outside and adjacent drainage needs (unless ped or bike safety elements are at risk).
- e. Assume PE engineering to begin after Jan 2025.

15. T202320012 Nanticoke Heritage Byway – Gateway Signs and Informational Kiosks (Sussex County)

- a. Develop a plan for kiosk installations and two wayfinding along the Nanticoke Heritage Byway.
- b. Awaiting proposal from consultant, but initial efforts expected to begin this fall/winter.
- c. Sponsor match will be obtained which was designated from the bond bill. Sponsor claims to have provided. This must be verified before PE.
- d. Meeting September 12 to focus on PE scope development. Sponsor and consultant expectations are needed and seem uncertain on both ends.

16. T202320007 Berzins Nature Trails (Sussex County)

- a. PE engineering continues with obtaining foundation boring information.
- b. Preliminary Plan is scheduled July 2024.
- c. Public workshop set for August 21.
- d. Semi-final plan is scheduled for October 2024.
- e. Natural Resources Permits will be needed.

17. T202320008 NE Front Street, Phase II, Milford (Kent County)

- a. Continuation of current construction west towards North Rehoboth Boulevard (1B).
- b. This project will not improve the lager intersection with Route 1B which is a capital project.
- c. May include a pipe/culvert replacement need, but under the City's initiative.
- d. PE engineering funding being set-up (current), but a town agreement needed with city.
- e. Understanding of the project scope is needed as complications with the project under previous TAP.
- f. Agreements sent to City and meeting coordination scheduled August 30.
- g. PE engineering design (assuming no complications) expected Sept/Oct.

18. T202320003 Northwest Front Street, Phase I, Milford (Kent County)

- a. Continuation of current decorative brick sidewalk east.
- b. This project does not intend to alter cross sections of road which is a capital project and uncertain in how to sequence construction if under TAP.
- c. PE engineering funding being set-up (current), but town agreement is needed with city.
- d. Understanding of the project scope is needed as complications with a nearby TAP phase with sidewalk detours prevailing with the city and/or property owners.
- e. Agreements sent to City and meeting coordination scheduled August 30.

19. T202320017 Town of Cheswold Pedestrian Safety Improvements (Kent County)

- a. Public Workshop held June 26.
- b. Based on funding availability or prioritization, construction efforts can implement a crossing location identified. There are three potential crossings.
- c. Efforts and coordination have been on-going with the town on its three street crossings (July/August) and refinements on them.
- d. Final estimates and concept crossing refinement report expected this fall. Coordination with the town is expected this fall on what measures can move forward based on limited funding sponsorship.
- e. Our section also anticipates a level of approval from DelDOT's Traffic Division.
- f. DelDOT would require a 20% project funding match from the town/sponsor prior to starting the design phase.

Concept Planning or Feasibility Assessment Only

20. T202320018 N. Dupont Road Pedestrian Safety and Streetscape (New Castle County)

- a. Planning and project feasibility assessment on-going. Efforts anticipated to be complete this fall.
- b. Effort will determine options or viability of options. The ultimate solution(s) or project recommendation may fall outside the TAP as a capital project and with right of way needs and on-street parking conflicts.
- c. Public Workshop Open House set for August 22 to present options.
- d. Final report with estimates and final recommendations and design/concept options anticipated late fall 2024.

21. T202320013 Town of Smyrna, Commerce Street Streetscaping (Kent County)

- a. Concept Planning and Visual Preference Survey Effort completed in July.
- b. Other Traffic Counts, Speed Study, and Accident Data already collected and documented in preparation of future streetscape recommendations and responses to public comment.
- c. Public Workshop occurred June 27 with the Town/sponsor which initiated public survey outreach.
- d. The Town/sponsor, consultant, and DelDOT will discuss the workshop & survey results to determine preliminary concepts or begin the concept development for the level and degree of streetscapes. This will occur August.
- e. Future public meeting is needed to present concept design recommendations. This is expected in fall/before end of year.
- f. Finalize report and streetscape recommendations in early 2024 with a final report and presentation to City Council spring 2025. This will divide the recommendations and implementation into short, mid, or long-term efforts.

Existing Projects Completed in Their Planning Concept Design or Those Likely Not to Move Forward

22. T202320020 Two-Way King Street at H. Fletcher Brown Park (New Castle County)

a. The City of Wilmington/sponsor does not agree with our recommendations and concept for the 16th Street continuous sweep turn (there is weaving safety) and other crossing measures on King/N. Market Street. The project will not move forward and as discussed multiple times and covered in Wilmington Initiatives? Notifications have been offered to sponsor (COW) that this project will be permanently terminated. In reality, the project anticipated scope is more like capital project. Formal expiation letter written and to be sent this August.

23. T202320004 West Fourth Street Bicycle and Pedestrian Improvements, Lewes (Sussex County)

a. The project is thought to involve a traffic pop-up demonstration and outreach effort likely for curb bump outs or dedicated bike lanes. There have not been any detailed or programed discussions with the community about anything in this corridor for this. City officials/sponsor seem to ignore even moving ahead. Multiple attempts to reach out only to be ignored. As projects stall or loose direction/interest, we advised that this project will be suspended and for the city to apply next time. A formal expiation letter has been written and expects to be sent this August. There may be a bike plan developed by DelDOT and coordinated/adopted by the city which is more appropriate for future TAP applications next time.

24. T202020001 Laurel Ramble Riverwalk (Sussex County)

- a. Concept design and planning package complete (Nov 2022) and shared with sponsor parties.
- b. Project may not move forward until other riverwalk phases are first complete and other properties along the river have a development plan. The future path unable to traverse under the rail bridge, but will circumnavigate around. We will advise City of Laurel/sponsor that new TAP application will be necessary since our projects, awards, scheduling, or funding do not operate on when private re-development of properties <u>may</u> occur. Apply when ready. Projects efforts are not awarded and then administered under a holding (or wait and see) pattern.

Others

- 25. Please also note that we have a FLAP grant for \$125,000 (all federal) which we intend to receive the funding in calendar year 2024 from FHWA. Efforts intended for National Park Service signage around the First State National Historical Park, New Castle County locations. A secondary planning study for pedestrian accessibility and safety needs around the NPS Delaware properties (all three counties) is also anticipated pending monies left over or newly awarded. It is our intention to also use our dedicated FLAP and state funds dedicated to FLAP in both efforts. Name and contract are being obtained this summer.
- 26. We also have a National Scenic Byway Federal Grant \$900,000. There will be state matches contributed. This shall involve non-motorized accessibility and assessment needs along the Delaware Bayshore Byway (all counties). And amenities such as rest room and kiosks in North Bowers and Milford (Kent County). We are currently obtaining funding requirements and project set-up information in July and August.
