- In the absence of consensus, a majority of the members present is required for an item to be recommended.
- The facilitator will seek the sense of the Advisory Group on a recommendation. If there is not unanimity or if a clear majority does not exist, written ballots may be used.

## Transit Redesign

- Delaware must explore a variety of options to promote a sustainable transit'system
  - Expand service to provide better access to jobs, schools, shopping centers and other destinations
    - Service hours and areas
    - Increase transit frequency
  - Improve bus stops and path of travel
  - Improve customer service and training for transit professionals
  - Explore transit fares and fare subsidy
    - Base fare in New Castle County has not increased since 1989
    - Base fare in Kent/Sussex has not increased since 2001















## Transit Redesign – Potential Paratransit Solutions

# Improved Access

- Create alternative transportation options to meet transit demands
- Strengthen eligibility process to ensure equal access
- Enhance Travel Training Program
- Improve transportation coordination statewide
  - Share service data
  - Inventory current resources and service gaps
    - Prevents duplication
    - Protects scarce resources

3,371	1,363	1,246	503	40.4%

#### Survey data entry is progressing:

- Of 3,371 surveys returned 1,363 have been entered in the database
- Of 1,363 surveys that have been entered, 1,246 have been through the initial geocode process
- There are currently 506 valid surveys with a geocoded O-D pair found through the first level of geocoding
- With additional review, we expect that the geocode match rate to reach 50%

## **Bus Operations**

- Restructuring of bus service in the greater Wilmington area
  - More Express routes
  - More City to suburban service
  - More downtown service
  - Transit supportive land use planning
  - Frequency of DTC bus service
- Rodney Square as a transit hub
- Redistribution of bus routes and bus stops from Rodney Square to King Street
- Amtrak Station as a transit hub
- Orange Street, Shipley Street or Walnut Street as a Transit Corridor
- Use of dedicated "bus only" lanes
- Potential for transit signal priority
- Downtown/Riverfront Circulator bus routes
- Trolley service expansion
- Potential coordination with private shuttles
- Bus operator restroom locations











## **Connectivity**

- Potential for multiple downtown transit hubs\*
- Potential for transit corridor link between downtown transit hubs
- Layover locations where buses would not serve customers, but would only be awaiting their next trip
- Rail, DTC bus and intercity bus
- Suburban transit hubs
- Transfer wait time
