BY THE WILMINGTON AREA PLANNING COUNCIL (WILMAPCO) RECOMMENDING USE OF SURFACE TRANSPORTATION BLOCK GRANT PROGRAM, CONGESTION MITIGATION AND AIR QUALITY IMPROVEMENT PROGRAM, TRANSPORTATION ALTERNATIVES PROGRAM, FTA URBANIZED AREA, AND FTA 5310 PROGRAM FUNDS

WHEREAS, the Wilmington Area Planning Council (WILMAPCO) has been designated the Metropolitan Planning Organization (MPO) for Cecil County, Maryland and New Castle County, Delaware by the Governors of Maryland and Delaware, respectively; and

WHEREAS, the United States Department of Transportation (USDOT) Regulations and Regulations, Metropolitan Planning Requirements require that the MPO, in cooperation with participants in the planning process, develop, and at least every four years, update the Transportation Improvement Program (TIP); and

WHEREAS, the use of federal funds for projects in the TIP are determined through a process of consultation and coordination between the Delaware Department of Transportation and WILMAPCO;

NOW, THEREFORE, BE IT RESOLVED that the Wilmington Area Planning Council does hereby approve the recommended programming of STBG, CMAQ, FTA Urbanized Area, FTA 5310, and TAP Funds for FY 2027 projects.

Notifications were made to sponsor (COW) that this project will be permanently terminated. City of Wilmington has expressed a renewed interest in the project due to ongoing public support and a new City administration. The City will have to re-apply for TAP funding during the next call for projects which may occur in spring 2026.
- b. The City did not re-apply for this project during the last application period held in Spring of 2026

23. T202320004 West Fourth Street Bicycle and Pedestrian Improvements, Lewes (Sussex County)

- a. The project is thought to involve a traffic pop-up demonstration and outreach effort likely for curb bump outs or dedicated bike lanes. There have not been any detailed or programmed discussions with the community about anything in this corridor for this. City officials/sponsor seem to ignore even moving ahead. Multiple attempts to reach out only to be ignored. As projects stall or lose direction/interest, we advised that this project will be suspended and for the city to apply next time. A formal expiration letter has been written and expects to be sent this August. There may be a bike plan developed by DelDOT and coordinated/adopted by the city which is more appropriate for future TAP applications next time.

24. T202320009 Old Brandywine Village, Streetscape Improvements, Phase III (New Castle County)

- a. This concept has been completed but because of the developing plans for the 12th street connector it is likely that most of the major improvements will be absorbed by that project in order to accommodate the new traffic patterns. What is left is not an ideal fit for the TAP program.

Others

25. Please also note that we have a FLAP grant for \$125,000 (all federal) which we intend to receive the funding in calendar year 2024 from FHWA. Efforts intended for National Park Service signage around the First State National Historical Park, New Castle County locations. A secondary planning study for pedestrian accessibility and safety needs around the NPS Delaware properties (all three counties) is also anticipated pending monies left over or newly awarded. It is our intention to also use our dedicated FLAP and state funds dedicated to FLAP in both efforts. Name and contract are being obtained this summer.
26. We also have a National Scenic Byway Federal Grant \$900,000. There will be state matches contributed. This shall involve non-motorized accessibility and assessment needs along the Delaware Bayshore Byway (all counties). And amenities such as rest room and kiosks in North Bowers and Milford (Kent County). We are currently obtaining funding requirements and project set-up information in July and August.
